## 3. CONTESTANTS

---

<b>Membership</b>	An <b>approved 2017 WTF Global License</b> (WTF Global Athlete License OR Global Official License) is required for all athletes and officials who wish to register for the G1 Belgian Open 2017. WTF Global License registrations & renewals can only be made through the WTF recognized Member National Associations and application should be made <b>at least 2 months</b> before the tournament starts to ensure the WTF license can be processed and approved in time. <b>There will be NO WTF Global License registration onsite.</b> View the <b>WTF Licence Registration Process</b> in the following <b>8 languages</b> :

Coaches need **GOL (WTF GMS number)** and **Continental Coach License** (if applicable).

## Age

According to ETU/WTF-categories:

- Cadets: born in 2003, 2004 and 2005
- Juniors: born in 2000, 2001 and 2002
- Seniors: born in 2000 and older

Athletes born in 2003 may compete as cadet or as junior (not in both).

Juniors born in 2000 may compete as junior or senior (not in both).

**Athletes can participate in only 1 category.**

Those who are not recognized as adults by law in their own country must provide a **written consent signed by the parent or legal guardian** wherein is stated that they accept the participation and all parts of the official invitation— **see attachment 1.**

## Equipment



PSS including e-head protectors from **KP&P** will be provided for all competitors. All contestants must bring their own WTF-recognized equipment e.g. groin-, forearm-, shin-, mouthpiece, gloves and sensor socks (compulsory).

## Graduation

Cadets must hold at least 4<sup>th</sup> Geup (blue belt).

Juniors and Seniors must hold at least 2<sup>nd</sup> Geup (red belt).

## Liability

All competitors participate at their own risk. The organization, the Flemish Taekwondo Union and/or the Belgian Taekwondo Federation shall not accept responsibility for any damages, injuries or losses sustained or incurred and specifically note that they also take no responsibility for any damages, losses, injuries or other consequences due to (directly or indirectly) acts of terrorism or terrorist threats. All contestants must bring their own documents and forms for any medical treatment in Belgium. If not, this will have to be paid in cash.

10 competition areas, all with electronic scoring system.  
Single elimination tournament system.

### Video Replay

For all categories on all competition areas.  
2 quota until and including semi-final; 1 bonus quota will be given in final when all quota have been used.

### WTF Ranking

Seeding of Senior Athletes will be based on the Feb 2017 Rankings (including events until end of Jan 2017).

### Protest

Only the official coach is allowed to protest, immediately after the end of the contest. An amount of **€ 150** will have to be paid for each protest. The decision of the referee chairman is final.

### Doping control

Some contestants chosen at random will be tested.  
The list of prohibited products will be equal to the list of IOC.

## 5. ENTRY

### Registration

Registrations are only accepted through the WTF Event Registration system: <https://www.hangastar.com/WTF/> and registration is only possible with a valid 2017 WTF Global License.

**! Registrations can only be made by the club admin of the team.  
Individual athletes won't have access to the registration system.  
Registrations onsite will not be accepted.**

### Entry Fee

Entry fees are obligated at all times. There will be no refund if a registered competitor/team fails to show up for the competition!

In case the competitor has not been removed from the list of participants before the deadline his/her team or official must fully (100%) pay the entry fee(s) for participation. In case of no show the invoice will be send to the team after the tournament.

### Modifications

For all modifications that are to be made after the deadline, an administration fee of **€ 25** will be charged. This must be paid in cash at the registration.

### Coach

For every 5 contestants within the same team, one coach is granted free admission, with a maximum of 3 coaches. An extra coach costs **€ 25**. Coaching is only allowed in sportswear (no dobok). All coaches must be 18 years or older. Coaches need GOL and Continental Coach License (if applicable).

### Spectators

Up to 9 years old: admission is free  
10 years old and older: **€ 10** (2 days)

### Hall Rules

Only the competitors and their coaches have admittance with their registration cards to the contest areas.

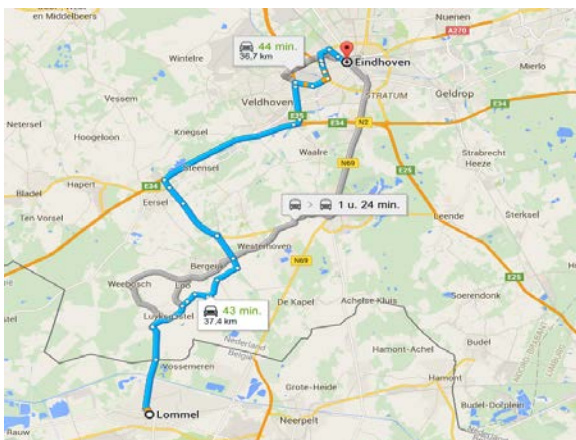
### Press

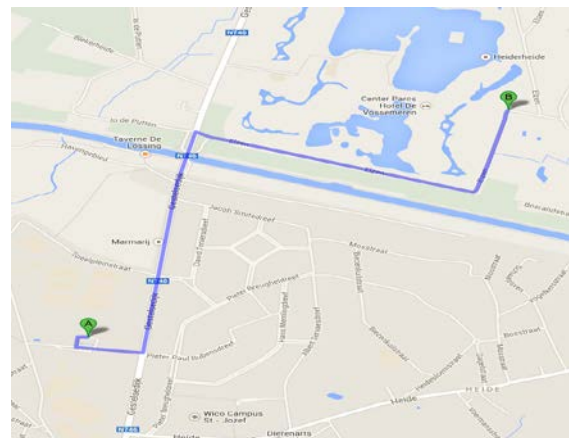
## 6. ACCOMMODATION
